Semen Transport Permit Fees and Requirements

1. Semen Transport Permit Fees:

- a. Fees for Stallion Owners currently NFHR members:
 - \$105.00 Applications made for a Semen Transport Permit **prior** to the first semen shipment.
 - \$205.00 Applications made for a Semen Transport Permit **subsequent** to the first semen shipment.
- b. Fees for Stallion Owners **not currently NFHR members**:
 - \$205.00 Applications made for a Semen Transport Permit **prior** to the first semen shipment.
 - \$305.00 Applications made for a Semen Transport Permit **subsequent** to the first semen shipment.

2. **DNA Typing**:

- a. All stallions must have a DNA type on file with the NFHR prior to transport of semen and before a semen transport permit will be issued.
- b. DNA Type Kits are available from the NFHR Registrar's office. Results are usually available within 2 3 weeks of the hair sample's mailing to the laboratory. All new DNA types will be automatically tested against DNA types on record to confirm parentage.

3. Semen Shipment:

The vial, straw or other container carrying semen from which the mare is to be inseminated is to accompanied by a completed NFHR Receipt for Transported Semen.
